



Professor Ethan Chiang is an Assistant Professor of Finance at Belk College of Business, UNC Charlotte. His research focuses on empirical asset pricing, portfolio management and performance evaluation, fixed income securities, and financial econometrics. He has published scholarly articles in leading financial economics and asset pricing journals, such as *Journal of Finance*, *Review of Asset Pricing Studies*, and *Journal of Empirical Finance*. His research has been recognized with best paper awards from the Belk College of Business, as well as international academic societies, including Financial Management Association, Eastern Finance Association (twice), and INFORMS. He has taught PhD Portfolio Theory, MBA Financial Management, and undergraduate Investments at UNC Charlotte. Professor Chiang received BA in Economics from National Taiwan University, MBA from National Chengchi University (Taiwan), and PhD in Finance from Boston College.
